BE ADVISED:

- 1. MEMBERSHIP IN CLUB PROPERTY:** Members are not authorized to leave the Club premises without their membership card. No. 22002, ASSUMES NO RESPONSIBILITY.
- 2. MEMBERSHIP CARD:** Members must carry their membership card on Club premises and use the card while on Club property. The membership card is the only way to access the Club premises, members and guests. "The usage and misuse of this badge are the sole responsibility of the member. Failure to use card, or to access the Club premises, members, and/or guests with unauthorised persons for admission or transference shall bring about a fine of \$100.00. Failure to return the card will result in a fine of \$100.00 and will constitute grounds for termination of membership.
- 3. LOSS OF MEMBERSHIP CARD:** In the event of membership card is lost, it is the member's responsibility to immediately report the same to the member who issued the card and to the Board. There is a \$50.00 fee charge for replacement of a membership card and the member is responsible for all costs prior to return of card. - 5. MEMBERS:** Membership does not provide an automatic right to use Club property. Any member who would like to have or Club property must submit a request in writing. - 6. MEMBERSHIP TERM:** Annual Membership runs from January 1st to December 31st of each year. If a member fails to renew membership in time, membership application form (00075), a new membership card will be issued to self-cover the balance of the current year and the following year.
