BE ADVISED:

- ACCESS TO CLUB PROPERTY:** Members are not authorized to use or the Club property without their membership card. **NO CASH ALLOWED ON MEMBERSHIP CARD.**
- MEMBERSHIP CARD:** Members must carry their membership card on their person and use the card with all club property. The membership card is the only way to access the Club property, clubhouse and ranges. The name card number on the range is the only form of appropriate access. Failure to use your card to access the Club property, clubhouse, public ranges will constitute grounds for revocation of membership. Misuse, taking others to or use or leaving of membership card is PROHIBITED and will constitute grounds for immediate revocation of membership.
- LOSS OF MEMBERSHIP CARD:** In the event a membership card is lost, it is the member's responsibility to immediately report the loss so that access may be suspended and a new card issued. There is a \$25.00 charge for replacement of a membership card and all ranges the member's access to is now gone before printing. - RANGES:** The Club ranges are 4-100000000 00471 000070-000 0007 000000000 in about on the Club range.
- SAFETY:** Membership does not provide an automatic right to hunt on the Club property. Any member who would like to hunt on Club property must submit a request to safety. Permission is limited and eligibility is determined by the Board. Please refer to the Club Rules & Regulations for the proper procedure.
- ANNUAL MEMBERSHIP TERM:** Annual Membership runs from January 1st to December 31st of each year. Membership dues are due in December on the grounds.com, with a grace period through March 31st of the current year. After the expiration of the grace period on March 31st, any current member will be dropped from the membership roster and will be considered a new member (involving a \$25.00 initiation fee when re-activating a suspended membership application form 10070). A new membership card after September 30 will cover the balance of the current year and the following year.
